- The citizens in *Agenda 21* receive their instructions and news from something called "Social Update Meetings." It's there that they are told what behavior is acceptable. Does this not sound familiar to Diversity Equity and Inclusion and ESG?
- Glenn's book, *Agenda 21*, was aptly named after "Agenda 21," which was first proposed by the United Nations back in 1992.
- In 1997, the Kyoto Protocol was established to start taking Agenda 21 from concept to reality. In the end, too many nations—including us—pulled out. But that didn't stop them.
- Now, it is getting a rebranding.
- In 2015 Agenda 21 received its first rebranding. The UN NOW called it Agenda 2030, but it was all just the same proposals from the original Agenda 21 doctrine.

# Agenda 21 is now being pushed from corporate boardrooms.

- 2020 was a massive turning point for Agenda 21 and Agenda 2030.

- For most of the biggest corporations in the country right now, hiring the most talented people and promotion based *on merit* is no longer the goal.
- It's now a *quota* system to make sure every race and gender is fully represented.
- *Representation* drives employment—not talent and ability.
